1. INTENDED USE

The Miracle-Ear App (The App) is intended for Android and Apple iOS smartphones to adjust certain hearing aid parameters.

The app must be used only with your own personal hearing aid(s).

The hearing aid(s) must be fitted by a professional hearing care specialist.

Miracle-Ear does not accept any responsibility if the App is used with other hearing aid(s) and if it is used not respecting national, state and international laws on the use of mobile app and Bluetooth technology. It is recommended, the user follow the instructions provided in this document.

The App can be used on smartphones with Bluetooth® Low-Energy (BT-LE) capability and is compatible starting with the versions of iOS 14.3 and Android 8. Please check the version of your smartphone operating system before use. It is recommended to access the internet once a week in order to ensure the app will be kept up to date.

The hearing aid(s) can only be connected to one mobile app.

Prior to use, the user must read and accept the informed consent.

3. SAFETY PRECAUTION



Some mobile smartphones have touch sounds or keypad tones, which could simulate a streaming to the hearing aid. Make sure that all touch sounds and keypad tones are deactivated in your smartphone settings.



In case of unusual environment disturbance, the hearing aids may not respond to the App. Move away from the disturbing environment.



Please make sure to read the hearing aid user guide and use it whenever an App malfunctioning occurs.





Do not use a loud volume level for long periods or settings that are not provided by the hearing care specialist, otherwise it is advisable to consult your hearing care specialist.



In case of incident or malfunctions of the App, please contact immediately Miracle-Ear, your audiologist or medical assistance.



Do not use your smartphone while driving a car, motorcycle, or scooter.



Keep your smartphone at least 15 cm away from the pacemaker implant site or other medical devices with similar characteristics; for example, do not keep your smartphone in your breast pocket if the pacemaker is implanted in the chest or on your belt if it is implanted in the abdomen.



Avoid extended smartphone use.

4. COMPANY BACKGROUND

Amplifon has developed a mobile smartphone application (app) which will be branded as a Miracle-Ear device. Miracle-Ear is a reseller of hearing aids and associated accessories and services. Miracle-Ear does not manufacture hearing aids but sells hearing aids manufactured by other brands.

5. PRODUCT DESCRIPTION

The device under consideration is the app which will run on a mobile smartphone with Bluetooth capability. The mobile app is stand-alone software which is designed to be used in combination with the hearing aid via Bluetooth connection; it is configured to allow the user to change the hearing aid current volume (between the security thresholds set by the hearing care specialist) or current program with a user-friendly interface.

The hearing aid is a medical device whose configuration for a specific user should be programmed exclusively by a hearing care specialist via a fitting software which is provided by the hearing aid manufacturer. The maximum volume of the hearing aids, set by the manufacturer, ensures the safety of use. During the fitting process the hearing care specialist establishes the hearing aid available programs and volume settings; e.g. the maximum and minimum amplitude of sound that can be generated by the hearing aid, according to the security limits established by the manufacturer and the hearing aid loss of the patient, etc. and the functionalities of the hearing aid buttons, e.g. long press to change the current program, short press to change the current volume.

Miracle·Ear®

The hearing aid can be controlled and used without the support of the mobile app, but the app will provide an easier way for the users to change the current program, change the current volume settings or to reduce the background noise which can interfere with the perception of the primary signal (e.g. spoken voice).

The mobile app reports the list of the hearing aid programs programmed into the hearing aids by the hearing care specialist. The user can change the program and/or the volume of the hearing aids. The volume decrease/increase step is defined by the hearing aid volume settings, provided by the hearing care specialist during the fitting process, which is below the security threshold set by the manufacturer for the maximum amplitude of sound that the hearing aid can generate.

Also, the hours of hearing aid daily usage are displayed in the app, the hearing aid provides the total hearing usage and the app calculates the average daily usage of the hearing aid. The app also provides a suggestion of daily usage, which is defined by the hearing care specialist e.g. 8 hours per day.

The Miracle-Ear app is a remote control for the hearing aid/s that can perform only the actions set-up by the provider and programmed through Harmony, actions that cannot be modified by the user, may depend on the specific HA technology level used and the peripheral devices connected; prior to use of the Miracle-Ear app, the user must read and accept the informed consent.

5.1. App installation

The user can download and install the Miracle-Ear app from the Apple Store or Google Play Store for free. The steps to install the App are the following:

- On iOS devices (Apple devices):
 - 1. Go to App Store and search for the App.
 - 2. In the search result, tap the App.
 - 3. Tap "GET" and then "INSTALL".
- On Android devices:
 - 1. Go to Google Play Store and search for the App.
 - 2. In the search result, tap the App.
 - 3. Tap "INSTALL".

When the installation is complete, the user will see the App's icon on the home screen of his/her mobile device and the app is ready to be used. The Miracle-Ear App enables the user to easily and intuitively pairing with the hearing aids, just follow the steps shown in the App (see section 6.1).

The Miracle-Ear App can be closed by the user like any other application on the device, depending on the operating system used (iOS or Android).



6. USER INSTRUCTIONS

6.1. Pairing – connection with the hearing aids

The pairing is the process during which the user connects the hearing aids to the mobile app.

The user should pair her/his smartphone to the hearing aids throughout a Bluetooth low energy connection in order to enable the mobile app to interact with the hearing aids.

The app will guide the user through the pairing process between hearing aids and phone, explaining the steps to follow in order to have a successful connection.

To successfully start and end the Pairing flow with an iOS device, which also includes pairing in the device settings (if you have any questions about the Mfi¹ devices involved, please contact your hearing care professional), the steps that the user should follow are:




Figure 1: Start Pairing Flow - iOS

- 1. Start the App, turn the hearing aids on and wait until the App locate your hearing aids (Figure 1);




Figure 2: Search and connect iOS settings

- 2. Once identified, the user will see a video with instructions to pair the hearing aids into smartphone settings (MFI) (Figure 2);




Figure 3: Connecting - iOS

- 3. Follow the steps shown in the video and return to the App, wait for the pairing flow to end (Figure 3);
- 4. A successful pairing between App and hearing aids will be notified by a successful page (Figure 4);
- 5. The user will automatically see the homepage when the pairing flow is complete (Figure 5).

For all Android devices, in general for all acoustic devices that do not require pairing in the iOS operating system settings (not Mfi), the flow is managed within the App and follows the steps below:




Figure 6: Start Pairing Flow - Not Mfi

- 1. Start the App, turn on the hearing aids and wait for the App to locate the hearing aids (Figure 6);
- 2. Once identified, select the hearing aids (Figure 7);
- 3. Wait for the pairing flow to complete ²(Figure 8);
- 4. The pairing between App and hearing aids will be notified by a successful page (Figure 9);
- 5. The user will automatically display the homepage when the pairing flow is complete (Figure 10).

During the flow, the user has instructions to proceed correctly in each step: how to start and/or restart the hearing aids according to the type of power supply if rechargeable (Figure 11) or battery powered (Figure 12), how to enable Bluetooth, how to enable the localization services.

Hearing aids take time to start up, so make sure they are turned on properly.

6.2. Program selection




Figure 13: Home page

Once the hearing aids are paired, the mobile app will show in the home page the list of the available programs with the current one highlighted. The user can swipe through the list in the home page and select the desired program (reported as "A" in Figure 13). If the user selects a different program, the user must wait until the program icon is highlighted (turns white).




Figure 14: Control Center C: Program List

If the user taps on the program icon or on the "Connected" icon in the lower menu (reported as "B" in Figure 13), a new section of the app is opened called the Control Center, where the user can change program by swiping to the right or to the left (reported as "C" in Figure 14). If the user selects a different program, the user must wait until the program controls in the middle of the screen are enabled.

6.3. Volume control




Figure 15: Home page

On the app home page, the user can control the volume of the hearing aids interacting with a touch of the slider (reported as "E" in Figure 15). If the user has left and right hearing aids the volume will be regulated on both hearing aids. The user can also mute/unmute the hearing aids by selecting or deselecting the mute interface (reported as "D" in Figure 15).




Figure 16: Control Center

In the Control Center, the user can regulate the volume of the left/right hearing aid independently, interacting with the corresponding volume slider ("F" and "H" in Figure 16) and can mute the left or right hearing aid ("G" and "I" in Figure 16).

6.4. Streamer




Figure 17: Adaptive streaming volume ON

If the selected program is associated to a hearing aid accessory ("Streamer"), the user can also control the volume of the streamer interacting with the corresponding volume slider (Figure 17).

If the hearing aid supports the Adaptive Streaming Volume functionality, switching on the toggle button ("Fs" in Figure 17), the user can activate this functionality so the volume of the streamer automatically adapts to the environmental noise.

6.5. Hearing Direction




Figure 19: Control Center

If the hearing care specialist has enabled hearing direction settings for a specific program, in the Control Center the user will be able to regulate the hearing aid directionality. By tapping on the control element in Figure 18 the hearing direction can be set to "front", "left", "right" or "back". When the hearing direction is set to FRONT, the user can fine-tune the configuration of the FRONT state by a slider "K" (Figure 19). If the user selects the "J" button, hearing direction will be automatically set according to the hearing aid(s) settings (Figure 19).

6.6. Hearing Aid(s) usage




Figure 20: Home page N: Indication of daily usage O: Suggested daily usage

The hearing aid provides the total hearing aid usage and the app calculates the average daily usage of the hearing aid. This value is displayed in the home page as reported in "N" in Figure 20.

A recommendation of daily usage is defined in accordance with the hearing care specialist, e.g. 8 hours per day, and a message to remember the suggested daily usage is reported in the home page ("O" in Figure 20).




Figure 21: Home page

When the user reaches the daily usage goal the home page highlights it with a different visualization of the daily usage, as reported in Figure 21.

The app also stores information securely about how the user interacts with the hearing aid, e.g. if the user changes program, volume, hearing aid daily usage, etc.



6.7. Hearing aids Settings

The section can only be reached when the user has paired the hearing aid with the app, from the "Me" section.




Figure 22: Me – Hearing aids setting

If your hearing aid supports the features (³), there will be a dedicated "Hearing Aids Settings" item (Figure 22). By accessing the menu, the user can choose which features to activate or deactivate, managing them independently.

6.7.1 Edge Mode+

Edge Mode+ is a feature that helps reduce background noise and provide clarity of speech (Figure 23).

The user can manage the function directly from the Homepage of the App, in fact, after activating it from the dedicated menu (Figure 23), the user will see a button appear on the Homepage (Figure 24), selecting it an environmental analysis will be performed (

Figure 25) which will suggest to the user the best solution to hear better based on the conditions in which he is at that moment (Figure 26).




Figure 27: Homepage Edge Mode+ - Active

The user will then return to the Homepage with the function activated (Figure 27), which can be deactivated at any time.

6.7.2. Tap Control




Figure 28: Tap Control menu

Tap Control is a feature that allows you to activate some operations on the hearing aid by tapping, for example, stop or start streaming audio by simply double tapping the hearing aid (Figure 28).

6.7.3. Call Control

If the device supports the functionality, users who use an iOS device can activate "Call Control" with their phone once the hearing aids have been paired.(Figure 22)

The feature allows the user to accept, reject or terminate calls through the hearing aid by simply pressing/tapping the device. The user will have the option to enable/disable the confirmation tone every time he/she answers/rejects/ends a call by pressing on the related button.

6.7.4. WiCross

WiCross⁴ is a feature that allows the customer to perform a cross balance in order to hear better (Figure 30).

6.8 Treble and Bass




Figure 31: Control Center – Treble S1: Bass slider S3: Treble slider S_R: Reset button

If the hearing aid supports the treble and bass functionality the user can access it from the Control Center. Interacting with slider "S1" the user can regulate Bass, Middle with "S2", treble with "S3", Ultra with "S4". The user can reset treble and bass to 0 by selecting the reset button "SR" (Figure 31).




Figure 32: Control Center – Treble, Middle, Bass and Ultra

6.9 Find My Aid

The user can locate the hearing aid(s) by using the GPS location whenever the hearing aids are not connected with the mobile app.

If the user has enabled the GPS location settings on their smartphone and has already paired the hearing aid(s) at least once, they can see the last GPS location of the hearing aids




Figure 33: "Me" menu

- Accessing the "Me" menu item and then "Find Hearing Aid" (Figure 33);




Figure 34: Find My Aid

- By tapping on the "Connected" item if the HA are disconnected (reported as "B" in Figure 13) and "Find my Aid" button (see Figure 33 and Figure 34).




Figure 35: Find My Aid – Locate my Device



6.10 Personal Program




Figure 36: Control Center – Personal Program W1: button to save a Personal Program

The user can save a modification of a program's advanced settings into a new personal program. In the Control Center, as the user starts changing something in the advanced settings of the program, the button allowing the user to save his/her changes to a new personal program is showed ("W1" in Figure 36). If the user decides to save a new program, the summary page will be presented allowing the user to control the values of each modified setting and highlighting the new values in red. Moreover, the user can enter a program name to associate his/her new personal program (Figure 38).




Figure 37: Personal program - Summary Page

Once created the new program is activated, and it is distinguishable in home page and in the Control Center as reported in Figure 37 and Figure 39.

In the page "Edit Program" (Figure 40), the user can personalize the name of the program and delete it tapping the button W_3 (Figure 40).




Figure 38: Home page - Personal Program




Figure 40 - Edit Personal Program




Figure 39: Control Center - Personal Program



6.11 Always on: notification on Android devices

For all Android devices, on which a successful pairing has previously been made, a notification will be available in the operating system notification center that will maintain the always-on connection between the hearing aid and the phone, even if the app is closed.

This feature will allow customers to be always connected and informed about the connection status and running program even without opening the App.

The user can turn the feature on or off or decide to disable the automatic reconnection if the phone is turned off and on again.

The user can:

- enable or disable the feature directly from the App settings by pressing on the Y₁ button (Figure 42),
- enable automatic re-connection every time the cell phone is rebooted by pressing on the Y₂ button (Figure 42).




Figure 41: Always on – menu




Figure 42: Always on - details
